# PUBLIC HEARING on proposed Extension of the Claverack (AB Shaw) and Mellenville Fire Districts

RF read a description of the proposed changes to the boundaries of the Claverack (AB Shaw) and Mellenville Fire Districts to cover the properties currently in the West Ghent Fire Protection District of Claverack. RF explained that the Town is not in the business of "fire protection." He stated the State is more comfortable with the proposed change.

Stephanie Sussman, resident, questioned where map of the proposed changes can be found. RF stated this will be on posted on the Town's website.

Robbie Speed, representative of Mellenville Fire Company, wanted to remind the public that both fire companies have been taking care of this area for over two years. He stated that putting these boundary changes in place just solidifies what has already been happening.

**HIGHWAY SUPERINTENDENT REPORT** - Department has completed servicing of trucks along with installing plows, wings, and sanders. Have pulled up the blacktop on the basketball courts at the Town Park to prepare for subbase and base for repaving. Have been patching all zones as needed. Have worked two small snow events.

**DOG CONTROL REPORT –** *On file with the Town Clerk* 

HISTORIAN REPORT - Working on program called "America 250." Looking for new president of Claverack Historical Society. Money has been given for a historical sign for the Fuller-Ginsberg property. A check was given to the Town Bookkeeper who will deposit and write a check for marker. Commemoration event will be held in the spring. Discussion of the VanDeusen cemetery on Bates & Snydertown Roads. Is there something on a Town level that should or can be done? KW said that the first thing would be to determine if it is private property. The Town is responsible for the County cemeteries. SH said she would have to contact the State — if the Town does it there are all kinds of rules and regulations that would have to be followed. RF advised he could research and try to find out who owns - that would be a starting place. Jean will do more research as well. Stephanie Sussman, resident, asked if it would be possible to get school kids involved in clean up. KW advised first we must find out who owns. Jean thought student involvement would be awesome. Jean will be also looking into the burial grounds on Bates Rd extension.

SUPERVISOR REPORT – Spoke with Paul Cognetta, Vice President of Operations at Penflex to attempt to figure out issues with Churchtown Fire Company and dissolving the fire protection district. Also, spoke with Terry Hannigan, Attorney, who has been assisting with the boundary issues with AB Shaw/Mellenville fire companies regarding West Ghent. Met with Village of Philmont Board along with SH regarding the Blues Festival proposed for Town Park in 2025. After this discussion, contacted the individual in charge of the proposed Festival and suggested possibly holding it at the old Ockawamick school grounds rather than at the Town Park, as the facility is just not a good fit for something this large. Together with SH, met with the Town of Greenport regarding 2024 water rates. Arrived at an agreement that they will not be raising the rates at this time. Attempting to put together more information on the history of the rates and increases for further review and discussion. Talked with Supervisor in Greenport. They are considering a roundabout at 9H-66, Bells Pond, and correcting the one by Bridge as well as putting one on Catskill side. Advised the end of year meeting with the full Board of Supervisors is at 3pm on 12/27/23.

**Stephen King. resident** - Thanked the Town for utilizing the electronic speed signs. He is hoping to see the signs on Route 23B in spring. KW advised he spoke with County Engineer and is trying to have the speed limit lowered to 40 all the way through.

**Stephanie Sussman, resident – E**xpressed gratitude to Katy Cashen for her time in serving the constituents of the Town. Ms. Sussman stated that Hudson City Schools are now live streaming Board meetings and Village of Philmont is recording meetings and posting. She questioned where the Town is at with this? DC advised that with the Memorandum of Understanding approved at tonight's meeting with the County, the Town can now "piggybank" with them to get things for the County's price. The hope is to be able to have this in the works relatively soon.

**Susan Roberts, resident** – Asked KW if he had an update on boundary of her property? KW advised he will go in and speak with Ray at the County and then let her know what he says. At that time, if Ms. Roberts is not satisfied with the County's answer, she will need to get her own survey. Ms. Roberts asked when he would be having this conversation and KW advised next week.

**John Bradley, resident** – Advised of a Climate Smart program called "Solarize." People may have signed up for this in the past. It is his understanding that "things" will be happening for the town and a few residents very soon. He is hopeful the Town savings will be \$3,000- \$4,000 per year. Mr. Bradley is not sure how individuals will know if this program is "active" for them.

**Mike Brandon, Town Judge** – Advised the Court will be facing real challenges in the coming year due to results of recent vote. He is asking all (Board and Residents) to have vision moving forward.

**Brenda Shufelt, resident** – Expressed her thanks to Katy Cashen. Invited all to attend a reception in honor of Katy on January  $5^{th}$ , 2024 at 5:00pm at the Claverack Library.
