CLAVERACK TOWN PARK RULES AND REGULATIONS

To enhance and promote the safety, well-being, and enjoyment of everyone in their use of these facilities, the following regulations are adopted. Any persons violating any rules or regulations will be removed from the park and may be prosecuted to the fullest extent of the law.

Please initial each item below.

- _____ 1. Absolutely **NO FIREARMS** of any kind, slingshots, bows and arrows, or similar items are allowed on park premises.
- _____ 2. **NO ALCOHOL** to be consumed, distributed, and/or sold on park premises without prior written approval from the Claverack Town Board.
- _____ 3. Absolutely **NO SMOKING OR VAPING** allowed on park premises. This is a smoke-free premises.
- _____ 4. **NO DOGS** or other animals are allowed on the park premises at any time.
Following are exceptions to this rule: Service animals that are ADA compliant or working police dogs.
- _____ 5. **ALL VEHICLES** must be parked in designated areas only. Vehicle speed shall not exceed 5 mph, and all vehicles shall yield to pedestrians using the park.
- _____ 6. **NO MOTORIZED RECREATIONAL VEHICLES** (i.e., mini bikes, ATVs, snowmobiles, etc.) are allowed on park premises
- _____ 7. **NO SKATEBOARDS, ROLLERBLADES OR ROLLERSKATES** are allowed on park premises.
- _____ 8. **NO** person in the park shall use **OFFENSIVE, DISORDERLY, THREATENING, OBSCENE** or **INSULTING LANGUAGE, CONDUCT** or **BEHAVIOR**
- _____ 9. **NO** person shall **OPERATE ANY SOUND EMITTING EQUIPMENT** at any time in such a volume as to unreasonable annoy or disturb any persons or neighbors.
- _____ 10. **NO** person shall cause **PROPERTY DAMAGE** to park premises inclusive of buildings, equipment, or grounds.
- _____ 11. **NO LITTERING** on park premises. Trash and rubbish should be placed in proper receptacles.
- _____ 12. **NO BURNING** or **CAMPFIRES** on park premises.
Grills (**for charcoal use only**) are available for public use throughout the park.
- _____ 13. **ALL YOUNG CHILDREN** on the playground are to be **SUPERVISED** at all times.
